

# **Big Cottonwood Canyon Flea Market (BCC Flea) 2026 Vendor Agreement**

## **\*\*Prohibited Items and Activities:\*\***

The sale of food or beverage for on-site consumption, firearms, fireworks, or any unlawful items is strictly forbidden. Additionally, MLM products, political merchandise, or counterfeit items are not accepted. BCC Flea staff reserves the right to deny admission to specific items and/or vendors at their discretion. Vendors who fail to accurately describe the items they are selling may be denied participation.

## **\*\*Vendor Confirmation and Fees:\*\***

Vendors will receive a confirmation of approval and an invoice upon acceptance. All vendor fees must be paid in advance to reserve a space. The fee is \$65 for a 10' x 10' space. Vendors supply their own tables, chairs, canopies/shades, etc. All fees are non-refundable except in the case of market cancellation due to inclement weather. Late notice cancellations will not be rescheduled.

## **\*\*Setup and Canopy Requirements:\*\***

Spaces will be assigned at the discretion of BCC Flea operators. Vendors agree to set up their designated space between 7:30 AM and 10:00 AM. All vehicles must be moved from the market area by 10:00 AM.

## **Canopies Must Be Tied Down with 40LBS Per Leg AT ALL TIMES.**

**This includes setup and breakdown time, always attach weights asap and never leave a weightless canopy unattended.**

Strict compliance with this will be enforced or you may be asked to leave.  
Extra weights may be rented for a fee (\$10/set of 4) first come, first serve.

## **\*\*Tax and Regulatory Compliance:\*\***

Vendors are responsible for the payment of all local, state, and federal taxes. The event is held on watershed-protected US Forest Service land. Vendors agree to abide by all applicable state or local health, fire, and safety codes and to take immediate corrective action when notified of violations. No dogs are permitted. Vendors must leave the premises clean of all refuse and materials.

## **\*\*Liability and Indemnification:\*\***

Vendors assume all responsibility for any damage or injury to the public caused by their products, equipment, and merchandise. BCC Flea is not responsible for any loss incurred due to weather, theft, or negligence. Vendors take sole responsibility for accidents, damage, and injury caused by their vehicle.

The undersigned agrees to release BCC Flea, its agents, employees, operators, and Brighton Resort, its agents, employees, and operators from any and all claims of any kind resulting from participation in the Big Cottonwood Canyon Flea Market. BCC Flea is not liable for any injuries caused by weather of any kind.
